April – June 2020 Statistics

During April – June of 2020, The Beaches of Fort Myers & Sanibel hosted just over 450,000 visitors who spent an estimated \$404 million while visiting – a 44.4% decrease in spending year-over-year. Visitors staying in paid accommodations spent an estimated \$308 million (76 percent of the total). Lee County's lodging industry experienced a year-over-year decrease in average occupancy and average daily rate, resulting in a decrease in revenue per available room (RevPAR).

Bed tax collection

The preliminary resort tax collected for June 2020 was \$2,337,503, a 19.9% decrease over June 2019 preliminary collections of \$2,918,447. Fiscal year-to-date preliminary tourist tax collections are \$31,582,734, a decrease of 13% year-over-year.

Airport news

During June 2020, 237,706 passengers traveled through Southwest Florida International Airport, a decrease of 59.5% in passenger traffic compared to June 2019. Year-to-date, passenger traffic is down 39.6% from the same period last year.

Consumer sentiment study and Lee County visitation update

Joseph St. Germain, DSG, presented an overview of the most recent wave of data collected for the consumer sentiment study on vacation travel. He reported that about half of consumers still plan to take a vacation between now and September, while 2 in 5 continue to postpone their vacations until 2021or beyond. Research shows that consumers would be most motivated to visit a destination/attraction that advertised how they are prioritizing safety for their staff and guests once it is safe to travel again. St. Germain also gave a brief summary of the second quarter research report, which showed that both visitation and visitor spending is down year-over-year for the period between April and June. Four out of 10 domestic visitors staying in paid accommodations during the spring of 2020 came from the Midwest. Miami-Fort Lauderdale, Minneapolis-St. Paul, Chicago, New York and Detroit were the top domestic feeder markets for Lee County. Canada delivered the largest share of international visitation in the spring season at 4%. Guest satisfaction remains high at 96%.

Sports Development update

Jeff Mielke, sports development director, reported that 39,476 room nights sold in the months of January through June 2020 with direct visitor spending of \$19,468,946.

New business

- 1. The TDC unanimously approved Beach and Shoreline funding recommendations for fiscal year 2020-21, allocating \$9,107,155 to 16 projects throughout Lee County.
